




Quote of the Week beginning 28.9.20:



Thank you once again to all parents and carers for your continued support this week. We can't quite believe there are only 2 weeks until the October holidays!

We continue to be encouraged, noting that almost every learner is supporting our risk assessments by complying with the mitigations currently in place to keep everyone safe. Learner walks continue to show excellent engagement in lessons, and we have reviewed and reiterated our risk assessment mitigations to all staff and pupils to ensure that everyone is compliant with our risk assessment. The latest version will be up-loaded to the school website early next week.

Tonight, would have been our annual 'Evening of Entertainment', a wonderful event, celebrating the talents of our former pupils and giving our current senior pupils valuable opportunities to develop skills and responsibility. This is our one major fund raiser in the school year and all funds raised have been used for the 'School Fund', which is solely for resources to support pupils in school. Without this event, we do not have as much money to spend, however, our Charities Committee have met this week and there have been some great ideas which we will share in due course.



Here are the updates for this week:

Virtual Assembly:

This week's Virtual Assembly will be shown on Friday 2nd October and registration will be extended for 5 minutes to ensure that there is enough time to view and for the Register Teacher to read the daily bulletin notices to all learners.

Ellon Academy Staffing Up-date:

The Scottish Government has allocated additional staffing budget to all schools and we have now decided the best way to utilise these funds for the benefit of our learners:

The posts awaiting local authority approval prior to advertising are:

- 1 FTE Principal Teacher Digital Learning (Temporary Contract for up to 23 months)
- 1 FTE General Supply Teacher (Temporary Contract for up to 12 months) for the purpose of providing time for faculties for development in light of digital/blended learning
- 2 FTE Teachers of Additional Support Needs (Additional Government funding for ASL)

You will need to have a MyAberdeenshire account to do this. If you pay for school meals online through IPayImpact, you will have this already. If you require any help with setting any of this up, please contact the school office on 01358 281150.

In previous years, we have sent you our Annual Data Check Forms in paper format. These forms ensure the school holds accurate and up to date information for children and parents/carers. This year we shall be asking for this information electronically. This is done through parentsportal, hence the reason for our request.

S6 Study:

S6 pupils are currently using the Sunken Social Area for their study periods and they sign in at the reception window to ensure we can account for their attendance. Pupils have been instructed to wear their face coverings during study time and there are only 4 pupils per table permitted for now.

S6 pupils are now permitted to sign out on a Wednesday and Friday afternoon after their PSE class.

First Aid Information:

Given the circumstances we find ourselves in, please see below some ways in which you can help support our First Aid team:

- Due to the number of pupils arriving at First Aid feeling ill as a result of not eating/drinking anything, could you please reinforce to your young person the importance of a good breakfast and eating well throughout the school day.
- To help support our First Aid staff, please do not arrive at school to collect a sick child unless the call comes from the school. The First Aid team will assess the situation and call you to collect your child if they feel it is necessary. Sometimes pupils are well enough to return to class and continue with their learning.
- First Aiders are there to provide help with minor ailments only. They are not qualified nurses. On arrival at school please do not ask your child to visit First Aid for treatment for anything other than minor ailments.
- First Aid do not keep any form of medication e.g. paracetamol, to be dispensed in school, which has not been previously authorised via a form by Parent/Carer & Rector. Please discuss this with your child as many visits to First Aid are to request pain relief.

If there are any issues with these points, please contact your young person's Guidance Teacher

Quarantine Guidance

The Foreign & Commonwealth Office currently advises British nationals against “all but essential international travel” except for destinations which no longer pose an unacceptable risk to British Travellers (Travel Corridor). Travel disruption is still possible and national control measures may be brought in with little notice.
